

The 17th Annual Martin Tansey Memorial Lecture

ACJRD are delighted to announce that booking is now open for the 17th Annual Martin Tansey Memorial Lecture, with Prof. Maggie O'Neill, Professor in Sociology & Criminology, University College Cork, speaking on *'Women and the Criminal Justice System: Gender Matters'* on Thursday, 2nd May 2024 in the Criminal Courts of Justice.

The lecture draws upon a long history of research with women who come into conflict with the law, who engage with the criminal justice system as victims or offenders. In keeping with Martin Tansey's life's work and the values he promoted that underpin independent criminal justice research, the lecture highlights the usefulness of interdisciplinarity and creative methods for centring the narratives of the actors involved and developing pathways to better knowledge and understanding, education and reintegration.

Alternative Ways of Seeing – An exhibition of work by people in custody

'Alternative Ways of Seeing' is a national exhibition of artwork produced in prisons and curated by artist Eddie Cahill, a former prisoner himself, and an inspirational figure in the world of prison arts. Cahill together with Tom Shortt, Arts Officer for the Irish Prison Service, travelled the length and breadth of the country, selecting a body of work which spans all the prisons in Ireland and displays a wealth of skills taught within the prison education system. Cuan – new statutory agency to tackle and reduce DSGBV

The new Domestic, Sexual and Gender Based Violence (DSGBV) Agency, Cuan, was formally opened on the 23/02/24 by Minister for Justice Helen McEntee. Implementing the governments zero-tolerance policy for DSGBV is the agency's main objective. It will aim to do this by providing funding for domestic and sexual violence services, by leading public awareness campaigns, and importantly by increasing refuge spaces for domestic abuse victims. Criminal Justice (Engagement of Children in Criminal Activity) Bill 2023

New legislation, which has completed all stages of debate, will criminalise grooming children into criminal activity. The Criminal Justice Bill 2023 makes it a criminal offence to compel, coerce, direct or deceive a child into engaging in criminal activity. It also makes it a criminal offence to induce, invite, aid, abet, counsel or procure a child into engaging in criminal activity. The offence is punishable by up to 12 months of imprisonment on summary conviction and 5 years on indictment. To view the Bill click here.

Proposed Family Courts Bill will create two-tier family justice system

The Bar of Ireland is <u>calling for urgent amendments</u> to the draft Family Courts Bill (2022) to avoid the creation of a two-tier family justice system, and in order to ensure there is fairness for all families before the courts.

The Bar of Ireland and The Family Lawyers Association are generally supportive of the Bill – but have strong concerns about the proposal to reallocate most divorce, judicial separation, and co-habitation proceedings to the District Court. This will create a two-tier family justice system.

Belgium criminalises Ecocide on a National and International Level

Belgium has become the first EU country to criminalise ecocide, and to recognise it as an international crime. The federal parliament have approved a penal code which will criminalise ecocide, an offence which includes severe, large-scale and irreversible crimes against nature such as extensive oil spills. The penal code will allow for the conviction and punishment of individuals in the highest positions of decision-making power and corporations with 20 years in prison and a fine of €1.6 million. Recent Publications

Policing and Racial Discrimination in Ireland: A Community and Rights Perspective

This report highlights and details the perceptions and experiences of racial discrimination in Ireland of people from ethnic minority communities when interacting with members of An Garda Síochána. The report makes 18 recommendations, including six to Government, one to the Policing Authority and 11 to An Garda Síochána. They include:

- Government should immediately mandate the collection of disaggregated data pertaining to race, ethnicity, religion, gender and disability across the entire Irish criminal justice system to properly understand how racial and ethnic minorities are treated at each section of the justice system.
- Government should meaningfully implement Action 1.5 of the National Action Plan Against Racism to eliminate any type of policing practice that targets specific racial and ethnic minority groups by 2025.
- An Garda Síochána develop and deliver specific training on racial profiling that addresses, amongst other things, unconscious bias, cross-cultural communication and intercultural understanding, the different manifestations of racial profiling and the impact on individuals.
- An Garda Síochána prioritise diversity in recruitment to ensure that the diversity of Gardaí reflects the diversity of Irish society, including intersectional identities.

The Policing Authority published its Assessment of Policing Performance. This report offers an assessment on progress against the Policing Plan 2023 to the end of June, and acts as a mid-term evaluation of the Garda Síochána's performance against the Policing Priorities 2022-24.

This report is an important part of the Policing Authority's work, providing transparency to the communities that the Garda Síochána serves, the Garda workforce, and other stakeholders about policing performance, the oversight of policing, and the outcomes of that work. An Evaluation of the Provision of Psychiatric Care within the Irish Prison System

A report by the Office of the Inspector of Prisons has been published which identified key issues in the standard and quality of psychiatric care in the Irish Prison System and made recommendations to the government based on their findings. This inspection was carried out in February and March 2023, by a team including two international experts in forensic psychiatry. Among the key issues identified by the report were a lack of staff, inadequate environmental conditions, deficiencies in treatment within prisons, and a gross lack of system-wide clinical care pathways.

Neglect of prisoners with mental health difficulties exposes a prison system that is unfit for purpose

Fiona Coyle, CEO, Mental Health Reform said: "The findings of the Office of the Inspector of Prisons are deeply disturbing. It is clear that the State is failing many people in the criminal justice system with mental health difficulties. The inhumane conditions and inadequate care in the prisons indicate serious human rights violations."
