Executive Summary

The Association for Criminal Justice Research and Development (ACJRD) has hosted a wide array of events and seminars during 2018. These included our 21st Annual Conference entitled "Unlocking the Power of Data for Criminal Justice Research, Policy-Making and Practice", and the 5th Annual Irish Criminal Justice Agencies Conference entitled "Towards a Trauma Responsive Criminal Justice System - Why, How and What Next?" which was a collaboration of the ACJRD, the Irish Youth Justice Service, The Probation Service, The Department of Justice, the Irish Prison Service and An Garda Síochána. The ACJRD also held Working Groups seminars and events at which attendees had the opportunity to contribute their opinions and share perspectives. The ACJRD also provided administrative support for the 2018 Parole Board Conference.

The Association also continues to further current and future Research opportunities, maintains a membership base and a number of Working Groups and also contributes to the criminal justice community in Ireland via quarterly newsletters and continued memberships and relationships with other not-for-profit organisations who share common ground with the objectives of the ACJRD. In 2018 the ACJRD began collaboration with Northumbria University and Queen's University Belfast on a UK-Irish Criminal Justice Cooperation Network.

1. ACJRD Research

The ACJRD Research-Sub-Committee oversaw the following projects during 2018:

Conducting Efficient and Effective Criminal Justice Research Projects Best Practice, Current Difficulties, Future Needs

The Association believes that quality research findings are essential to a more effective and responsive criminal justice system. To assist future research efforts, the Association wishes to explore how collaboration between criminal justice policy makers, practitioners and researchers might be further enhanced to their mutual benefit. To this end a study has been commissioned to consider what works best in conducting criminal justice research projects, what difficulties arise in terms of data, access, etc., and what actions might be taken to support efficient and effective research projects into the future. The ongoing study involves the compilation of the views of policy makers, practitioners and researchers who have recent experience of criminal justice research projects.

This study has been funded by a grant from The Children's Act Advisory Board.

11th Annual Martin Tansey Memorial Lecture, 17th April, 2018




3. Membership

Three categories of ACJRD membership per annum are on offer: Student €25, Individual €35 and Organisational Membership €155. Organisational Membership is based on a flat rate: this includes all members of that organisation, with up to five members able to attend any one ACJRD event at special rates.

Benefits to ACJRD members include; special rates for ACJRD conferences and seminars, publications on research and conference/seminar proceedings, priority bookings at all ACJRD events, circulation of the newsletter, the option to become involved in the ACJRD Working Groups and access to a range of peer networks.

Compared to 2017, membership rates for 2018 have increased in all types of membership. There were 41 Individual Members, 34 Organisational Members and 18 Student Members in 2018.

10. Collaborations Associations and Memberships

The UK-Irish Criminal Justice Cooperation Network

In 2018 the ACJRD began a collaboration with Northumbria University and Queen's University Belfast on a UK-Irish Criminal Justice Cooperation Network.

The UK-Irish Criminal Justice Cooperation Network is an initiative which is funded by the Arts and Humanities Research Council and led by Northumbria University, Queen's University Belfast and the Association for Criminal Justice Research and Development in Ireland. The funding commenced on 1st October, 2018, and the project will run, initially, for 18 months. The network aims to bring together policymakers, practitioners and academics to consider the implications of Brexit for criminal justice cooperation between Ireland and the UK. The Network collaborators are deliberately including a range of expertise, policy areas and perspectives in order to make the Network as beneficial as possible to all participants.

The Children's Rights Alliance

The Children's Rights Alliance is a coalition of over 90 non-governmental organisations (NGOs) working to secure the rights and needs of children in Ireland, by campaigning for the full implementation of the UN Convention on the Rights of the Child. It aims to improve the lives of all children under 18, through securing the necessary changes in Ireland's laws (strengthening children's rights in the Constitution), policies and services. The ACJRD maintained its membership of the Children's Rights Alliance in 2018.

The Wheel

The Wheel is a support and representative body connecting community and voluntary organisations and charities across Ireland. Established in 1999, The Wheel has evolved to become a resource centre and forum for the community and voluntary sector. The ACJRD maintained its membership of the Wheel in 2018.

The Irish Penal Reform Trust

The Irish Penal Reform Trust (IPRT) is Ireland's leading non-governmental organisation campaigning for the rights of people in prison and the progressive reform of Irish penal policy.

Established in 1994, IPRT has a well-established role as an independent voice in public debate on the Irish penal system. IPRT is committed to reducing imprisonment, respecting the rights of everyone in the penal system, and progressive reform of the penal system based on evidence-led policies. The ACJRD maintained its membership of the Wheel in 2018.
