Celebrating 20 years of Innovation in Justice



2016 is a big year for the ACJRD. We are celebrating our 20th anniversary! Over the last 20 years, our seminars and our Conferences have been the vehicles by which we have endeavoured to achieve our Mission Statement of "informing the development of policy and practice in justice." In addition, our Vision to bring "Innovation in Justice" continues to be a driving force in our work.

ACJRD Ltd, formerly the Irish Association for the Study of Delinquency Ltd, was established in 1996 by the late Martin Tansey, The Hon. Mr. Justice Michael Moriarty, Judge Gillian Hussey, Seán Redmond, Kieran O'Dwyer, Bernard Owens, Her Hon. Ms. Justice Mary-Ellen Ring, Chief Superintendent Seán Feely, Seán Aylward, Robert Eager, John Lonergan and Tom O'Reilly. The Association was inspired by the Scottish model (Scottish Association for the Study of Delinquency).

In 2006 the name of the Association was changed to The Association for Criminal Justice Research and Development - ACJRD Ltd.

The current Council comprises Maura Butler (Chairperson), Jane Farrell (Secretary), Eugene Corcoran (Treasurer) and Council members, Gerry McNally, Jim Mitchell, Michelle Shannon, Yvonne Daly, Doncha O'Sullivan, Shane Kilcommins, John McCormack, Robert Olson and Patricia Flynn. The Hon. Mr Justice Michael Moriarty is our patron.

Over the last 20 years, ACJRD has hosted eighteen Annual Conferences and numerous seminars, commissioned research, sponsored prizes in 3rd level institutions, and made submissions to the Joint Committee on Justice, Defence and Equality. Since 2014, ACJRD has helped to organise the annual Irish Criminal Justice Agencies Conferences. Recent initiatives include an Essay competition for third level students.

Our members are of paramount importance to us. We have student, individual and organisational members from all sections of the criminal justice system.

The Association employs a Manager and an Administrator, both on a parttime basis.

The Criminal Justice System in Ireland is constantly evolving and we are proud to say that we intend to continue to be a part of this evolution.

The issues facing young people leaving state care include: Lack of familial support and relationships; Lack of community support and relationships; Homelessness; Criminal behaviour; Mental health; The rental market; Physical well being; Literacy; Pregnancy; Parenting; Life skills; Emotional well-being and support; Mild disabilities.

This seminar will look at the supports in place for young people leaving state care at 18 years of age, where it started and how it has transitioned.

ACJRD is pleased to announce that **Dr. Anne-Marie McAlinden** of Queen's University Belfast will deliver this year's Martin Tansey Memorial Lecture. Dr. McAlinden will speak on "The Reintegration of Sexual Offenders". Dr. McAlinden is a Reader, and Director of Research in the School of Law at Queen's University Belfast. Her main research interests lie in the areas of the management of violent and sexual offenders, institutional child abuse, and restorative justice where she has published extensively. Dr. McAlinden is currently working on a third book on 'Child Sexual Abuse and Exploitation by Children and Young People'. Her first book 'The Shaming of Sexual Offenders: Risk, Retribution and Reintegration' (Oxford, Hart Publishing, 2007) was awarded the British Society of Criminology Book Prize 2008 for the best first soleauthored book published in the discipline in the previous year. Her second sole-authored monograph, "Grooming" and the Sexual Abuse of Children: Institutional, Internet, and Familial Dimensions' was published by Oxford University Press in 2012 as part of the prestigious Clarendon Studies in Criminology Series.

This year's lecture will be held in the Jurors' Area at the Courts of Criminal Justice, Parkgate Street, Dublin 8, (*pictured above*) at 5.30 pm on **Thursday, 7th April, 2016**.

Martin Tansey was a founder member and Chairperson of the ACJRD. Each Spring, the ACJRD marks the contribution which Martin made to Criminal Justice in Ireland and to this association with a Memorial Lecture.
