ACJRD is pleased to announce that **Professor Shadd Maruna**. Professor of Criminology in the School of Law, University of Manchester, will deliver this year's Martin Tansey Memorial Lecture. Professor Maruna will speak on "Desistance as a Social Movement".

Professor Maruna was previously Dean of the School of Criminal Justice at Rutgers University-Newark (2014-2016), He has worked at Queen's University Belfast, the University of Cambridge, and the University at Albany, SUNY. His book, "Making Good: How Ex-Convicts Reform and Rebuild Their Lives" was awarded the Hindelang Prize for "outstanding contribution to criminology" in 2001.

More recently, Professor Maruna has received the Hans Mattick Award for Distinguished Contribution to Criminology in 2014, and the inaugural Research Medal from the Howard League for Penal Reform in 2012. He has been a Soros Justice Fellow, a Fulbright Scholar and an H. F. Guggenheim Fellow. He is also the editor of the book series "Psychology, Crime and Justice" for American Psychological Association Books, and co-edited the book "Fifty Key Thinkers in Criminology" with Keith Hayward and Jayne Mooney (2010).

History of the Martin Tansey Memorial Lecture

The late Martin Tansey, who was head of The Probation Service from 1971 until his retirement in 2001, was a founder member and Chairperson of the ACJRD. Martin was strong in the belief that rehabilitation of offenders was a primary social objective and consequently, he was often referred to as a 'founding father' of Irish community sanctions. His recognition of the principle that community support is a vital cog in rehabilitation continues as an intrinsic objective of those who support community sanctions as an alternative to incarceration.

Martin has been honoured since 2008 by the ACJRD through the hosting of the Martin Tansey Memorial Lectures. These lectures have focused on topics which were intrinsic to Martin's dearly held views of offender rehabilitation and his vision for sharing expertise amongst members of the Criminal Justice Community in an effort to influence how stakeholders engage with their work.
