ACJRD Annual Conference 2017

The **20th ACJRD Annual Conference** will be held on <u>Friday, 6th October, 2017</u>, in The Spencer Hotel, Excise Walk, Dublin 1.

The theme of this year's Conference is "*The Brexit Impact on Criminal Justice Co-operation in Ireland*".

This conference will appeal to policy makers, those working in government agencies, professionals, practitioners, academics and those and civil society groups from a wide range of disciplines within the Criminal Justice System. Non-members of ACJRD are welcome to attend the Annual Conference.

Closure of St. Patrick's Institution

On 6th April, 2017, the Tánaiste signed three legal instruments under the Prisons Act, 2015. The effect of these three Orders was to close down St. Patrick's Institution and subsume the only remaining wing of the St. Patrick's building – 'B' wing - into Mountjoy Prison, all with effect from 7th April, 2017.

In practice, up to 31st March all 17 year olds committed to St. Patrick's Institution were transferred shortly thereafter to a special unit in Wheatfield Place of Detention. The 17 year old boys currently in Wheatfield will not transfer to Oberstown but will remain in the adult prison system until they complete their sentence or 'age out' - this process is expected to take approximately nine months.
