"Bail Supervision Scheme" Seminar

The ACJRD seminar 'Bail Supervision Scheme' was held on Tuesday, 10th September, 2019, at the offices of the Irish Youth Justice Service at Miesian Plaza, 50-58 Baggot Street Lower, Dublin 2.

This seminar was presented by Tony O'Donovan, IYJS, Fiona Murphy, Extern, Stephen Coughlan, Extern and Dr. Catherine Naughton, University of Limerick.

The Bail Supervision Scheme (BSS) offers courts an alternative option to detaining a young person who comes before them by offering them the possibility of granting bail with intensive supervision.

By reducing the need for remand places, this also provides an opportunity to focus on developing successful community resources designed to prevent young people being detained in a youth justice facility and preventing them from entering further down the path of criminality.

Man Up West

Safe Ireland has launched "Man Up West", a new inspiring and brave campaign to harness the voices, concerns and activism of men and boys across the West of Ireland to play their role in helping to change the face of domestic abuse and coercive control in Connacht. This is Safe Ireland's latest "Man Up" campaign, which has been inspiring men to stand against domestic violence, to challenge abuse and support women and children since 2012.

Men are being asked to do three simple but powerful things to support the campaign:

- Get beyond the daft myths that sexism, domestic abuse and coercive control are out of character, or that "lads will be lads".
- Speak out and tell friends, family and colleagues that disrespect, sexism or stereotyping of girls and women isn't cool.
- Organise one event or day to highlight that West of Ireland men are taking the lead in calling out disrespect and abuse.
