# **14th Annual Martin Tansey Memorial Lecture**

Martin Tansey was the founding Chairperson of the Association for Criminal Justice Research and Development (ACJRD). Each year, ACJRD marks the contribution which Martin made to both Criminal Justice in Ireland and to this Association with a Memorial Lecture in spring.

Charlie Brooker, Honorary Professor, Centre for Sociology and Criminology, Royal Holloway, University of London will present his lecture "Probation and Mental Health: Do We Really Need 'Equivalent' Care?" at 5.30 pm on Monday, 24th May, 2021.

Charlie Brooker has been a researcher and academic for over thirty years. His main interest was in psychosocial approaches for the care of people with serious mental health problems up until 1995 when he was professor of mental health both in Sheffield and Manchester. Since then, he has almost exclusively researched aspects of the Criminal Justice system and mental health. This work has taken him into police stations, prisons, courts, sexual assault referral centres, and, in the last 10-15 years, probation services. # **Reflections on a pandemic year, with ACJRD founder**

Mr. Justice Robert Eagar**, **Seán Aylward**, Chairman of the Board of SOLAS and former Secretary General of the Department of Justice and Equality, and **Professor Seán Redmond**, University of Limerick - discussed how the Covid 19 pandemic has impacted the Criminal Justice System. The event was moderated by **Ellen O'Malley Dunlop**, Psychotherapist, Group Analyst and Adjunct Professor at UL's School of Law, who enabled a most interesting and informative evening for ACJRD Members.

# **Working to Change**

On Friday, 20th November, 2020, Minister for Justice, Helen McEntee TD, launched the report, *'Working to Change-social enterprise and employment strategy 2021 - 2023'*. This strategy sets out ambitious targets to increase the employment options for people who have criminal records and is supported, amongst others, by the Irish Prison Service and The Probation Service and by IASIO who currently host the Social Enterprise Initiative. ## **Greentown Reports and Intervention Programme**



**Greentown Project**: For the last five years, the Greentown project has lifted the lid on a hidden crime problem in Ireland, uncovering significant evidence of children's engagement in crime networks. The research indicates that up to 1,000 children across the State could be involved with a criminal network.

Three of the reports are locally based case studies. The <u>Greentown Report</u> and the <u>Redtown Report</u> focus on network activity in two provincial towns. The <u>Bluetown Report</u> is an examination of criminal networks in one Dublin location. The fourth report, <u>National Prevalence Study</u>, is a national survey which assessed the prevalence of problems identified in the Greentown study across Ireland. Taken together, the reports provide detailed examinations of the features of criminal networks that operate in locations where children were detected for involvement in high levels of burglary and drugs for sale and supply. The national study permits an estimation of the size of the problem across the State.

This innovative project, a partnership between the School of Law at University of Limerick, the Department of Justice and the Department of Children, Equality, Disability, Integration and Youth (DCEDIY) provides new insights into how criminal networks attract and confine children, encouraging and coercing them to be involved in serious crime and limiting their opportunities to escape their influence.

**Intervention Programme**: This programme is being implemented on a pilot basis in two locations. These pilots will get underway shortly and the lessons learned from the pilots will have a key influence on the development of the Department's policies and interventions in the youth justice area. The new intervention programme will commence work with two local communities to implement the four core elements that make up the Greentown programme:

#### Network disruption

By examining the network, the University of Limerick research team will identify the means by which local children are recruited and retained. This element of the programme will identify and target individuals involved in cultivating relationships with children for crime, and employ legitimate means to frustrate this activity

#### Improving Community Efficacy

Local activities designed to improve the ability of the local community to withstand network influence and take back control of public spaces

#### Improved Pro-Social Opportunities

Pulling out the stops to encourage and incentivise children involved in a criminal network to re-engage with school, training or to secure and sustain employment

#### Improved Family Functioning

An intensive case-work relationship with families where children are engaged with crime networks. This element of the programme will seek to improve parenting capacity, acknowledging that parents may have client relationships with key network actors

# **Circles of Support and Accountability**

Prevention Accommodation CE Community Enterprise PACE is a community-based agency that has been working with people with convictions for over fifty years. PACE Prevention Services consists of three separate programmes designed specifically to work with people with convictions for harmful sexual behaviour. These programmes work with people with complex needs who are considered to be at significant risk of re-offending sexually and need to be managed safely in the community. PACE works in partnership with the statutory services to prevent further harm. See https://paceorganisation.ie/.

**Circles of Support and Accountability (CoSA)** is one of these programmes and is a community-based initiative operating on restorative justice principles. Working in partnership with the Probation Service, An Garda Siochána and other agencies, CoSA assists individuals (Core Members) with convictions for harmful sexual behaviour to live a life free of crime and from harmful behaviour. The aim of the Circle is **preventing further victims**.

Based on restorative principles, CoSA trains volunteers to assist individuals who have been convicted of a serious sexual offence(s) in their efforts to live a life free of crime and harmful behaviour.

At 2pm on Wednesday, 26th May, 2021, CoSA will host, via Zoom, a webinar "*Spotlight on Prevention - Circles of Support and Accountability Preventing Further Harm*". Guest speakers include Rev. Harry Nigh, founder of CoSA, and Professor Kiernan McCartan.


The Department of Justice is inviting tenders for two pieces of research work .:
