### **Picture Your Rights**

On 10th June, the Children's Rights Alliance and UNICEF Ireland launched "Picture Your Rights – the Children and Young People's Report to the UN Committee on the Rights of the Child". The Report was presented by the young people who wrote the Report with a response given by the Minister for Children and Youth Affairs, Dr James Reilly, TD.

"Picture Your Rights" provides a snapshot of what it's like to be a young person in Ireland today, exploring critical themes that affect their lives. A wide-range of Issues are covered under four areas: Being Valued, Mind and Body, Living Together and Our Future. The report consulted with thousands of young people in all, capturing the views of children from 0-18: over 2,000 children were surveyed online, 500 students took part in discussions, there were over 250 submissions and 10 youth focus groups reports.

The Report was written by a project team of 31 young people from all over Ireland and from a variety of backgrounds, nominated by members of the Chilldren's Rights Alliance and community youth groups. To view this report, click on the link below -

## On the Margins

The Jesuit Centre for Faith and Justice has developed a new resource for young people (aged 13-16 years) called 'On the Margins'. The module which includes twenty-seven lessons explores issues of social justice and focuses in particular on how society responds to crime and the use of imprisonment. Designed to be a resource for teachers and educators the module can be used in the classroom (CSPE) or youth group setting.

The module has been created to develop students' capacity for ethical reasoning, critical thinking and skilful analysis of social justice issues and to foster empathy for people living on the margins of society. To achieve these goals, the module encourages active and reflective learning.
