#### SPEAKER PROFILE THE HON MRS JUSTICE CATHERINE MCGUINNESS.



Mrs Justice Catherine McGuinness will launch the 13th annual ACJRD Conference.

She is currently president of the Law Reform Commission and is a retired Judge of the Supreme Court. Born in Belfast and educated in Belfast and Dublin (Alexandra College, TCD and the King's Inns) Mrs Justice McGuinness was called to the Irish Bar in 1977. In 1989 she was called to the Inner Bar, and called to the Bar of New South Wales in 1993.

In addition to her Judicial career, Mrs Justice McGuinness has served on An Bord Uchtála (the Adoption Board), the Voluntary Health Insurance Board, the National Economic and Social Council, the Second Commission on the Status of Women, and has chaired the National Social Services Board, the Board of National College of Art and Design, the Employment Equality Agency, the Kilkenny Incest Investigation and the Forum for Peace and Reconciliation.

#### SPEAKER PROFILE—DR AZRINI WAHIDIN

Dr Azrini Wahidin will speak on Older Women in Prison, Issues and Challenges.

She is a Reader in Criminology and Criminal Justice at the Centre for Criminal Justice Policy and Research at the University of Central England in Birmingham

Her research interests relate to the links between social exclusion, the 'deviant' body, crime and crime control, and social harm. She has conducted extensive prisons research focusing on both prisoners and uniformed staff. In particular Dr Wahidin's research has focused on elderly prisoners on both sides of the Atlantic; managing the needs of older offenders, the female prison estate, youth crime, theories of punishment, the lifer system and drugs in prison. She has recently completed studies on Real work in prison, educational needs in prison, managing the needs of older offenders and the experiences and needs of women in prison. In addition she has written in the areas of the body, time, sexuality, later life, feminist research methodology, particular the use of qualitative methods; research ethics and the politics of evaluation research

In 2008, Dr. Wahidin and associates were awarded a prestigious prize of Highly Commended Article of 2008 by Emerald publishers for literary award of excellence for an article published in International Journal of Sociology and Social Policy.

#### **SPEAKER PROFILE-ÉIMEAR FISHER**



Éimear Fisher will speak on Working Together Against Domestic and Sexual Violence.

She is the Executive Director of Cosc, the National Office for Prevention of Domestic, Sexual and Gender-based Violence. A career civil servant, Éimear has worked in a wide range of posts from central Departments to State agencies.

Most of these have been in the justice area including the Legal Aid Board. Éimear also worked for many years in the Courts Service - where she served as Registrar in the Dublin Circuit Family Law Court, the Dublin Civil and Criminal Circuit Courts and the Central Criminal Court - and in Policy divisions in the Department of of Justice, Equality and Law Reform.

Prior to taking up her current post, her work focussed on cross-cutting issues, including an assignment as Deputy Director of the National Children's Office, and a management position in the Department of Justice, Equality and Law Reform where she led efforts to streamline the State's assistance to victims of crime.

Éimear holds a masters degree in management practice from TCD, a diploma in Applied European Law from the Law Society of Ireland and a BA in Archaeology and Italian (UCD). She has also successfully completed several international programmes on leadership.

#### **EVENT REPORT—ADDICTION SEMINAR**

The ACJRD held a seminar on Addiction presented by Fiona Ryan, Director of Alcohol Action Ireland on Thursday September 23rd. in the Green Hall at the Law Society of Ireland.

Fiona's presentation focused on alcohol, young people and Juvenile Justice. She also highlighted the availability of alcohol to young people and also asked the questions of how we drink, how we think about alcohol and the attitudes that young people have towards alcohol. The level of advertising targeting young drinkers was also discussed.

The presentation was well received with members of the audience interacting throughout the seminar.
