Re-Imagining Imprisonment in Europe: Effects, Failures and the Future

The Jesuit Centre for Faith and Justice (JCFJ) held a launch of their most recent publication "Re-Imagining Imprisonment in Europe: Effects, Failures and the Future" on Thursday 5th of June in City Hall, Dublin. The Publication edited by Eoin Carroll and Kevin Warner was launched by Fr Greg Boyle SJ who is Executive Director of Homeboy Industries, a non profit organisation based in Los Angelus which serves high-risk formerly gang-involved men and women with a continuum of free services and programs. Introductory remarks were delivered by Professor Ian O'Donnell from the UCD School of Law.

Prison Visiting Committee Reports 2013

The Reports for 2013 of the Arbour Hill, Cloverhill, Cork, Dóchás Centre, Loughan House, Portlaoise, St Patrick's Institution and Shelton Abbey Visiting Committees were published on April 30th by the then Minister for Justice, Alan Shatter, TD. The function of Visiting Committees is to visit the prison to which they are appointed and hear any complaints which may be made to them by any prisoner. The Committees play a vital role in ensuring the quality of accommodation and catering, medical, educational and welfare services and recreational facilities.
