Turnaround Youth: Young Adults (18-24) in the Criminal Justice System

This IPRT report presents the case for the differential treatment of young adults aged 18-24 who come in contact with the criminal justice system, and is grounded in emerging evidence, best practice, and informed by input from young people with experience of the issues. The report gathers together the significant existing body of international research which demonstrates that several factors place young adults more at risk of becoming involved in offending behaviour and make the prison system an inappropriate and counterproductive means of dealing with young adults.
