"Life After Care" Seminar

The Juvenile Justice and Reintegration Working Groups of ACJRD held a seminar on "Life After Care" on Monday, 14th March, 2016. This seminar was presented by Don Bosco Care.

Don Bosco Care speakers at this event were Brian Hogan CEO, Rachel Valentine and Ciaran Kenny.

The seminar was extremely interesting and very well received by all those present. It looked at the supports in place for young people leaving state care at 18 years of age, where it started and how it has transitioned. This encompassed the following issues:

Lack of familial support and relationships; Lack of community support and relationships; Homelessness; The rental market; Criminal behaviour; Life skills; Mental health; Physical wellbeing; Literacy; Pregnancy; Parenting; Emotional well-being & support; Mild disabilities.

The State we are in 2016

SAFE Ireland warned that homeless figures and needs are being greatly under-estimated because over 4,000 women and children being accommodated on a yearly basis in emergency refuge accommodation are not being counted and recognised as being homeless.

At the recent launch of a new SAFE Ireland report The State We Are In, CEO Sharon O'Halloran stressed that women and children forced to leave violent homes are being caught in the cross-fire of the national housing crisis. She said that 37 services that participated in new housing research as part of *The State We Are In* are reporting that they have never seen things so bad for women and children.
