ACJRD 19th Annual Conference "Cybercrime"

The ACJRD Annual Conference 2016 "*Cybercrime*" took place on Friday, 7th October, 2016, at the Spencer Hotel in Dublin.

The Conference looked at the impact of Cybercrime on our society. Hugely informative, engaging and energetic the conference also raised awareness regarding the variety and extent of how crime can occur online. Six plenary speakers and eight workshop presenters covered different aspects of cybercrime including grooming, radicalisation, terrorism, hacking, theft, fraud, image based sexual abuse, online child sexual exploitation, cyberbullying, civil liberties, policing challenges, legislative reforms and prevention.
